With respect to withdrawals from an account at a financial institution, in addition to providing notice as stated above to REPUBLIC SERVICES, you may stop payment of a preauthorized electronic funds transfer by notifying your bank or financial institution in accordance with the procedures that it has established. Termination of a preauthorized electronic fund transfer does not affect your obligation to make timely payment to REPUBLIC SERVICES in some other acceptable manner.
4. To the extent allowable by law, the inability of REPUBLIC SERVICES in connection with Agreement is limited to the amount of any incorrect charge or withdrawal. REPUBLIC SERVICES will not be liable for any damages, whether direct, incidental, special, or consequential, including but not limited to loss of income or profits, whether or not REPUBLIC SERVICES had knowledge that such damages might be incurred. REPUBLIC SERVICES also will not be liable: (i) for your acts or omissions, including but not limited to improper or insufficient account or other information, (ii) if you fail to provide current information, should an account or other information change, (iii) if you violate any of the terms of the Agreement; and (iv) for loss, damage, or delay caused by events, REPUBLIC SERVICES cannot control, including, but not limited to, acts of God, weather conditions, acts of public enemies, war, strikes, civil commotions, or acts of public authorities with actual or apparent authority.
5. This Agreement will become effective with the next billing cycle follow the date stated below, upon approval in writing by Customer and an authorized representative of REPUBLIC SERVICES. This Agreement does not go into effect until approved in writing by REPUBLIC SERVICES.
